XII. PENALTY AND PUNISHMENT - DETAILS THEREOF

In addition to penalties mentioned in point XII, we would like to update on penalty after the closure of Financial year as below:

After 31 March 2025 (the period under review), pursuant to the proceedings initiated under the Show Cause Notice dated 28 May 2024 issued by the Securities and Exchange Board of India (SEBI) against the Company, SEBI, vide its order dated 15 April 2025, has imposed penalties of ₹2 lakhs under Section 15A(b) and ₹3 lakhs under Section 15HB of the SEBI Act, 1992 respectively. These penalties have been levied in connection with contraventions in continuance of Shri Manu M. Parpia (erstwhile Independent Director of the Company) as an Independent Director on the Board of the Company after the expiry of his tenure, along with other related matters under Regulation 25(2) of the LODR Regulations read with Section 149(10) of the Companies Act, 2013, Regulation 27(2) read with Regulation 4(1)(c) of the SEBI LODR Regulations, and Regulation 17(1C), 16(1)(b)(iv) and 30(2) read with Clause 12 of para-A of Part A of Schedule III of the LODR Regulations and SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123 dated July 13, 2023. The details of the same are set out in SEBI's said order, which is disclosed to the stock exchanges on 16 April 2025, and the Company has paid the penalty amount.
